#### **Public Announcements:**

# Brent Rygh, L.A.P.D. Senior Lead Officer

Theft continues to be a problem in Woodland Hills. Thieves steal from mailboxes and Fed-Ex/Amazon packages that are placed on porches.

Martin Lipkin questioned why patrols have been reduced in the West Valley area.

Officer Rygh stated that there is current reduced staffing in the Police Dept. and requested the NC promote a strong Neighborhood Watch system. LAPD staffing is 10,000 officers and priority policing areas must change every day.

John Strand recommended writing a letter to the Topanga commander asking that Officer's Rygh and Dinse be allowed to remain in their current positions and area. The letter will be written by the Public Safety Committee.

# Joaquin Macias, L.A. City, CD3, Deputy District Director, Councilman Blumenfield's office

Fire Station 84-the city has chained off the parking lot and renderings for the new park should be in next week. A meeting will be setup to share the plan with stakeholders. Councilman Blumenfield is working with the Valley Cultural Center to find ways to improve Warner Ranch Park. There are problems with transients and a decline in the surface of the park due to soccer players. The Councilman's Holiday Event collected 2,000 toys for needy children. There will be an economic community action team meeting at the end of this month.

**Matt Ehrenberg** – requested that the NC attend the Planning Hearing for restaurant Leo and Lilly. August Steurer commented that he has contacted the applicant's representative and Councilman Blumenfield's office with a PLUM request to hold the record open for a NC recommendation.

Bill Anderson reported that the NC will notify stakeholders that they can nominate street repairs in their area. The repairs will be completed by June 30th.

**Chris Rowe** - discussed the DTSC scoping of the Santa Susana Field Lab.

She believes that a review of documents will show there was not a reactor meltdown at the site.

**Dennis DiBiase** – will attend an Eldercare Ordinance panel discussion sponsored by Councilman Blumenfield. He asked for Board member and stakeholder input.
