Discussion and possible action concerning the following motion:

Dennis DiBiase made a motion to approve a PLUM Committee recommendation that the Board of the Woodland Hills-Warner Center Neighborhood Council support the project at 21711 Ventura Blvd in Woodland Hills seeking Project Permit Compliance per the Ventura-Cahuenga Boulevards Corridor Specific Plan, for exterior and interior remodel subject to the satisfactory receipt by the Board of a letter addressing the signage of the east side wall, public safety improvements to the driveway entrance, protected status of the Sycamore trees to be removed, the selection of vine species for the street wall planting, a commitment to maintain street trees until established, and a commitment to maintain planter boxes and living plants.

Discussion and Possible Action:
Boardwalk Burgers and Fries (SPP) (CUB)
(Formerly retail store for boxes)

19714 Ventura Boulevard, Woodland Hills, CA 91364

Dennis DiBiase made a motion to approve a PLUM Committee recommendation that the Board of the Woodland Hills-Warner Center Neighborhood Council support the project at 19714 Ventura Blvd. in Woodland Hills, seeking project Permit Compliance, per the Ventura-Cahuenga Boulevards Corridor Specific Plan, to permit a proposed restaurant in an existing 500 sf. building with existing Certificate of Occupancy for a restaurant on a narrow portion of a very irregularly shaped lot which will include an addition of 225 sf. floor area for ADA accessible restrooms and storage, plus an additional small patio adjoining a two-level patio structure. 6 additional parking spaces are provided onsite for the additional sf. Support for issuance of a CUB for the sale of beer and wine for on-site consumption is excluded and will be handled separately.

Item No. 3 - Scott Silverstein, Chair WHWCNC (12-046)

Discussion and Possible Action:

Chair, Scott Silverstein made a recommendation by the Chair of the Woodland Hills Warner Center Neighborhood Council for the Board to present a set of requirements to Board-member Martin Lipkin to abide by during his tenure as a re-elected Board member of the WHWCNC. The following items were debated at a publicly noticed Officer's Meeting held on September 27, 2012 and are being proposed by the Officers of this Board, to Mr. Lipkin, admonishing him for his unacceptable behaviors and breach of the Code of Civility on September 10, 2012 at a WHWCNC full board meeting and for numerous prior occasions. This agreement or any modification thereof as determined by the Board, shall be considered a stipulated agreement by this Board and Mr. Lipkin. The following terms and conditions shall be proposed by the WHWCNC Board:

- 1. An unqualified written apology to this board from Mr. Lipkin for prior incidents
- 2. An unqualified written apology by Mr. Lipkin to Ms. Alisa Smith, L.A. City, I.E.A.
- 3. A professional anger management class(s) shall be attended and completed by Mr. Lipkin at his expense

If this agreement is not strictly followed by Mr. Lipkin, this Board shall vote on proceeding with none, one, or more, of the following remedies or any other reasonable remedy this Board sees justified:

- 1. Removal of Mr. Lipkin from the Board (as specified in Bylaw E.5);
- 2. Censure of Mr. Lipkin by the Board;
- 3. Immediate removal of Mr. Lipkin from all committees until this Board rescinds said removal by vote

Discussion followed. This item was tabled to the next Board meeting.

Mr. Silverstein recommended that prior to the next Board meeting all Board members should become familiar with Rosenberg's Rules of Order, the WHWCNC Code of Civility, the Brown Act and Council member flow chart.
