#### **5. PLUM Committee**

PLUM Co-Chair Dennis DiBiase read a motion to support with CUB Conditions for ZA-2011-1916 (CUE) to be submitted for approval by the WHWCNC Board as follows:

In regards to the Department of City Planning case ZA-2011-1916 (CUE), the Planning, Land Use and Mobility Committee recommends that the Woodland Hills-Warner Center Neighborhood Council support the issuance of a CUE to permit the sale and dispensing of beer and wine for on-site consumption at 23305 Mulholland Drive in Woodland Hills in conjunction with an existing 1,328 square-foot restaurant known as Thai Chaba under the following conditions as agreed upon by the applicant:

#### 1. Restaurant Hours of Permitted Operation:

Monday 9:00 A.M. to 10:00 PM, Tuesday 9:00 A.M. to 10:00 PM Wednesday 9:00 A.M. to 10:00 PM Thursday 9:00 A.M. to 10:00 PM Friday 9:00 A.M. to 10:00 PM Saturday 9:00 A.M. to 10:00 PM Sunday 9:00 A.M. to 10:00 PM

- R-2. The restaurant shall be maintained as a bona fide restaurant with a kitchen as defined by the Los Angeles Municipal Code. It shall provide a menu offering an assortment of foods that shall be available at all times that the restaurant is open. The restaurant shall be promoted as a restaurant that primarily serves food. Menus shall be offered to all customers.
- R-3. Sales of alcoholic beverages shall be incidental to the sale of food at all time that the restaurant is open for business. Alcoholic beverage sales shall not exceed 30% of food sales. Alcoholic beverages may only be served while the kitchen is open for food service. Alcohol beverage service shall cease when the kitchen closes.
- R-4. All alcohol must be served with food from the Primary Menu. There shall not be a reduced late-night, substitute or ancillary menus for the purpose of serving alcoholic beverages.
- R-5. Dispensing of alcoholic beverages shall only be made from behind the counter where an establishment employee obtains the beverage. Self-service by patrons is prohibited.
- R-6. There shall be no "Happy Hour" which offers discounted drinks during specific hours nor shall free food or discounted food be offered as a substitute "Happy Hour."
- R-7. All personnel serving alcohol shall be 21 years of age.
- R-8. All owners, operators, managers and employees selling, dispensing and/or serving alcoholic beverages and spirits shall enroll in and satisfactorily complete the Los Angeles Police Department's "Standardized Training for Alcoholic Retailers (STAR)" within 30 calendar days of the start of their employment. A cumulative record of employee training shall be maintained for inspection, including each employee's name and the date of their last training. This record shall be available on-site for review of the police and enforcement officers and presented to the zoning administrator whenever requested. If there is a change in license, all new staff must take this training.
- R-9. The sale of distilled spirits by the bottle for on-site consumption is prohibited.
- R-10. Sale of alcoholic beverages for off-site consumption is prohibited.
- R-11. The installation of a bar in the restaurant is prohibited.
- R-12. Patio service of alcoholic beverages is prohibited.
- R-13. The restaurant shall not operate as a nightclub.
- R-14. The restaurant shall not operate as a Sports Bar.
- R-15. There shall be no adult entertainment.
- R-16. The restaurant is prohibited from being rented out to any outside promoter.
- R-17. No cover charge or membership shall be required for admission to the restaurant or sub-portion thereof.

No minimum age shall be required for entry.

- R-18. After-hours use of the restaurant is prohibited for any non-restaurant use.
- R-19. Amplified music or sound shall be not exceed 60 decibels outside the restaurant nor be audible beyond the premises controlled by the applicant.
- R-20. Live entertainment is limited to soft music or mellow vocal performances in which case issuance of a café license is required from the Police Commission prior to having live entertainment.
- R-21. No pool tables or coin operated electronic, video, or mechanical amusement devices shall be located within the restaurant premises.
- R-22. No booth or group seating shall be obscured from observation of patrons. Opaque or semi-opaque portions of partitions may not be higher than 54 inches.
- R-23. If televisions are located in the dining or bar area, all but one of them must remain muted.
- R-24. Consumption of alcoholic beverages on the property outside of the restaurant is prohibited.

- R-25. Signs shall be prominently posted in English and the predominant language of the restaurant clientele stating that California State Law prohibits the sale of alcoholic beverages to persons who are under the age of 21 years of age.
- R-26. Exterior advertising of any kind or type on the exterior or to the exterior from within which indicates or promotes the availability of alcoholic beverages is prohibited.
- R-27. "No Loitering or Public Drinking" signs shall be posted outside of the establishment in adjacent public areas.
- R-28. Congregating or loitering of patrons in the parking lot or on adjacent properties shall be prohibited.
- R-29. The applicant and/or property owner is responsible for maintaining the area adjacent to the premises under the applicant's control to be free of litter and graffiti.
- R-30. All graffiti on the site shall be removed or painted over to match the color of the surface to which it is applied within 24 hours of the occurrence.
- R-31. A 24-hour phone number shall be posted on a sign at the entrance or on the door for the public to comment/report complaints regarding the operation of the restaurant and a log shall be maintained of the calls received for the time, date and nature of the complaint. The log shall be made available to enforcement officers when requested.
- R-32. A copy of the conditions of the conditional use permit shall be posted in an employee area and a copy made available upon request to an enforcement agency.
- R-33. The Conditional Use Permit for the sale and dispensing of Alcoholic Beverages shall expire and require renewal at the end of seven years from issuance.
- R-34. Digital Recording via Security cameras of high definition quality shall cover all entrances during all hours of operation and recordings shall be retained for 30 days. Access to the streaming video from the cameras via internet is encouraged to be provided to the Los Angeles Police Department.
- R-35. There shall be California Licensed Security Guard(s) for the shopping center to provide surveillance outside of the establishment to the satisfaction of the Los Angeles Police Department. The requirements of the Police Department may be reviewed for a change in requirements on an annual basis.
