L.A.P.D. Senior Lead Officer Janet Zumstein

Special Presentation

Mr. Kevin James, President, Los Angeles Board of Public Works

The City of Los Angeles Board of Public Works

(BPW) is a five-member executive team that administrates the City of Los Angeles Department of Public Works. The Department of Public Works consists of over 5,400 employees who are responsible for design, construction, renovation and operation of public projects ranging from bridges to waste water treatment plants and libraries; curbside collection and graffiti removal; and maintenance of streets, sidewalks, sewers, streetlights and street trees.

Mr. James thanked all the candidates for running for the NC Board. Public Works has 5 Bureaus and an office of Community Beautification. He asks that every NC have a "public works liaison" who will work with the City. Current projects include: street lighting – LED light bulb conversion, new Sanitation

initiatives, an effort to redesign the "city contracting process" and a new Street Bond initiative for Nov. 2014 election.

Public Comment period:

Joyce Pearson – requested that the NC Board write a letter of support for an Orange Line Bus STOP to be placed at Canoga Blvd. and Reseda Blvd. The Transit Commission is supporting this endeavor. **Judy Levy** – concerned about the Swap Meet at Taft High School and the related car and pedestrian traffic.
