Call to Order - Chair Scott Silverstein called the meeting to order at 6:30 pm

Public Comment period:

a) The Walnut Acres Homeowners Association asked for the support of the Neighborhood Council as it relates to their opposition to Case # ZA-2011-2679-ELD-SPR, an Eldercare Facility proposed to be built at 6211 N. Fallbrook Ave., Woodland Hills, CA 91367.

b) Scott Silverstein called for a Special Meeting and a Motion to approve a \$1,000 expenditure to support the sponsorship of a Senior Symposium in partnership with One Generation and Councilman Dennis Zine's Office.

Comments from Councilman Zine's office

Sheree Adams, Senior Citize Specialist - addressed budget issues and concerns related to expenditures by the Council Office. She stated that consumer fraud against the elderly is on the rise.

Special Presentation

A presentation was made by Ms. Gomez of the City of Los Angeles Arts and Cultural Affairs of the proposed tile mural to be created and installed on the façade of the VCC band-shell in Warner Center Park.

Comments from the Board:

Several Board members discussed a variety of concerns that the mural's subject matter does not reflect the character and history of Woodland Hills. Several Board members felt the mural was not an appropriate design to be placed on the wall of the Lou Bredlow Pavilion in Warner Center Park as the pavilion is a contemporary design and the mural, as presented, is much more traditional in design and general character.
