Items for discussion and possible vote:

1.0 Value Capture Ordinance CPC-2017-2022-CA, ENV-2017-2023-ND

Discussion and possible action regarding an ordinance amending Sections 12.22, 12.24, 14.00, and 14.3.1 of the Los Angeles Municipal Code to align affordability requirements across the range of zoning entitlements that allow for increased density or floor area ratio beyond what is allowed by zoning. The ordinance aims at ensuring the creation of affordable housing through certain conditional use permits and public benefit projects. Currently all residential Zone Change, Height District Change and General Plan Amendment projects with more than ten units are subject to Measure JJJ's affordable housing requirements. There remains additional entitlement pathways to achieve significant density increases that are not subject to the provisions of Measure JJJ. These alternate entitlement pathways are the focus of the draft ordinance.
